Council Activity March 13 The Council approved the appointment of Rick Pitts to the Parks Board. This fills out the board. We express our humble appreciation to those of you who have and are currently volunteering.

The Council was briefed on the draft proposal and timeline for construction of the new city shop. It is hoped we will go out to bid April 13<sup>th</sup>. Permits are currently being processed to begin construction. Bid acceptance or rejection will be done by City Council after bid opening in early May.

The Council heard a report by Bruce Hooper of the Chehalis Valley Historical Museum, that there had been over 600 visitors since his last report. The council authorized the transfer of \$1,500 from Tourism funds generated by the motel tax to the museum. This completed funding agreed to by the City and the Museum in 2011.

Councilor Chris Hutchings reported that the Snow Removal Policy was still a work in progress and that it would be brought to City Council in the near future.

A complaint was mailed to the Council by a citizen regarding the danger of the large Sequoia trees on the north side of Fleet Park. Forrester Loren Hiner examined the trees and expressed concern because of a dead top in one of the trees and the size of some of the limbs. Several limbs had blown down in the past windstorms. So far, the damage has been restricted to the sidewalk. Councilor Pat Herrington advised Council that these beautiful trees were a reminder of why we are called the Home of the Tree Farm and of

the city's tree removal ordinance. It was agreed to contact an arborist for a professional opinion. This will be done as soon as possible.

Bids were opened on property which had been declared surplus. There were two bids and the council retired to executive session to discuss them. On their return, a counter offer was made to the high bidder asking to "complete the permitting process within six months". The high bid was for \$23,000 made by Woods at Sylvia Creek and it included granting the city a 10 foot paved access road, public parking, access to the river and provides for shoring up the river bank to prevent erosion. On March 13<sup>th</sup> the counter offer was accepted.
